___ 1. I/We will never leave our child at any team activity without making certain a parent/guardian is present. It is the parent's responsibility to make transportation arrangements to/from practices, games, and LPW activities. Players and cheerleaders shall not ride in the open bed portion of any vehicle.

___ 2. I/We will remain twenty-five feet away from the team when I/We attend any league practice, game, or competition.

___ 3. I/We will support our child's team managing staff whenever the team is gathered. As it would prove detrimental to the program, I/We will never gossip, nor will I/We ever express negative opinions whenever the team is gathered.

___ 4. I/We understand it is forbidden to use profanity, alcohol, tobacco, or illegal drugs during any Pop Warner activity. Shall I/We, or my child, exhibit any of the behaviors mentioned above, we will be asked to leave the facility and could face disciplinary action.

___ 5. I/We will be required to work a minimum of (2) volunteer league shifts (fireworks stand, snack bar, i.e.) on behalf of my player/cheerleader's team. If I/We do not show up for my/our assigned time(s) and shift(s), I/We will forfeit my/our \$50.00 deposit to the league. I/We understand additional fines may be assessed for multiple no shows and/or for not showing up for shifts during play-off/bowl season.

___ 6. I/We will have our child at practice and games on time. If they arrive late, they may be subject to disciplinary action. I/We also understand that if he or she is not picked up within 15 minutes of the end of practice, the child may be transported to the Lakewood Sheriff's Station.

___ 7. I/We will be held responsible for any equipment checked out to my child and will be required to pay for any item(s) that I/We do not return to the league.

___ 8. I/We will see that my child is properly dressed for his or her practice/game. I/We understand that no bandanas are allowed and that players or cheerleaders cannot wear jewelry.

___ 9. I/We understand that the medical insurance provided by Pop Warner football is secondary insurance to any insurance I/We may have on my child. I/We also understand that this secondary policy has a \$250.00 deductible that I/We will be responsible for should my child require medical aid.

___ 10. I/We understand that I/We will be required to participate in fundraising activities (i.e. car wash, raffles, etc.) for my child's team.

___ 11. I/We realize that there is a zero tolerance policy for any inappropriate adult behavior. For the benefit of all players and cheerleaders, I/We will be the finest examples of adult Citizenship, Friendship, Leadership and above all Sportsmanship. Infractions will result in removal from participation.

___ 12. I/We understand that all required paperwork must be turned in by the first day of practice or my child will not be allowed to participate in Lakewood Pop Warner Program until said paperwork is turned in.

___ 13. I/We understand that all required registration fees and/or deposits must be paid in full by our team's equipment handout date or he/she will not be allowed to participate in the Lakewood Pop Warner Program until said fees are paid.
